## **Job Description**

**Position:** Painting Supervisor

**Location:** Govan or Scotstoun, Glasgow

**Job type:** Full time

### **Overview of the role**

Denholm Industrial Services has an opportunity for an experienced Painting Supervisor to join the team, located at either our Govan or Scotstoun site. The successful candidate will be responsible for supporting the project throughout all aspects of the painting lifecycle, including but not limited to the direct supervision of the following trade groups:

- Pre-blasting cleaners
- Grit blasters
- Post grit blast cleaners
- Stripe coat painters
- Spray painters
- Brush/roller application painters
- Remedial painters
- Final Inspection painters

### **Key accountabilities**

- Have a full understanding of and the ability to communicate the standards and specifications being implemented across the contract, as regards surface preparation and coating application, and materials to be used.
- Complete a daily log of employees and hours expended against specific task, work type, materials used, problems encountered, and delays incurred that impact delivery.
- Ensure all activities are carried out by suitably qualified employees.
- Complete the allocated work scope, without risk to individuals' health and safety or risk to the environment, exceeding the minimum quality standard required, and within budget and programme.
- Understand the safety implications of good housekeeping and ensure that all areas are clean, tidy and safe.
- Act as first point of contact for industrial relations with the workforce and resolve any issues, where possible.
- Appraise and identify individual employees' training requirements based on work scope and monitoring of output.

- Agree with the IOP Paint Management the work scope to be undertaken and the labour/shift pattern necessary to complete the task(s).
- Ensure that all required materials are available to meet the planned programme and identify any potential shortfalls.
- Complete a daily log that identifies equipment inspection, highlighting any problems and rectification work taken or required.
- Ensure all potentially air-polluting activities are carried out within a suitable environment and that waste materials are disposed of correctly.
- Undertake 'Tool Box' talks, as appropriate.
- Have a sound understanding of the COSHH Regulations, Health and Safety at Work Acts, together with the requirements of the Safety Manual/IOP Safety Plan/Client Safety Requirements.
- Fully understand the potential hazards of painting operations for other trades working in the vicinity, ensuring sufficient warning notices and reporting systems have been implemented to avoid accidents or incidents, in accordance with client procedures .
- Ensure operatives are aware of and engage and comply with relevant HSE legislation and yard specific requirements.
- Ensure correct PPE is utilized at all times.
- Report any malpractice to the Paint Management and/or safety personnel.

### **Essential skills, experience and qualifications**

- Time-served painter with 5+ years of experience in the supervision of industrial blasting and painting processes
- Ideally experienced in Marine surface coating applications
- IOSHH qualified
- Ability to liaise with other trade groups
- Ability to work on their own initiative in a highly legislative and regulated environment
- Has detailed knowledge of the operation and use of all types of blasting and spraying equipment and is aware of the potential risks involved in the use of very high-pressure equipment
- Capable of reviewing the application techniques and measuring the quality of workmanship in line with the contract specification
- Able to undertake inspection requirements of their discipline, as necessary
